## James B. Bozeman Ministerial Scholarship Guidelines for Distribution of Funds

With appreciation to Mrs. Nell Bozeman for gifts to the First Baptist Church of Laurens in memory of her late husband, James B. Bozeman, designated by her to be used for scholarship aid to ministerial students, the following principles shall govern the distribution of earnings from the investment of said funds with Baptist Foundation of South Carolina.

- 1. A Scholarship Committee shall be responsible for the distribution of available scholarship funds to qualified ministerial students and institutions, with the Financial Secretary responsible for administering these grants upon the recommendation of the Scholarship Committee and with the approval of the pastor of the First Baptist Church of Laurens. The Scholarship Committee shall be composed of three church members who serve for an indefinite period with no rotation. This committee shall be appointed by the Board of Deacons and should a vacancy occur due to resignation or death, the Deacons shall appoint a replacement for the Committee.
- 2. Availability of scholarship funds shall be made known by the First Baptist Church of Laurens to each known eligible student personally and/or by public announcement no later than June 1 and November 1 of each year.
- 3. To be eligible to submit an application for scholarship aid, a ministerial student shall be defined as a person who is pursuing a full-time course (9 semester hours or more) of academic studies in preparation for a church-related vocation in the Christian ministry. The applicant must give written evidence of a vital Christian experience, a divine call, stability of purpose, and a growing Christian personality.
- 4. To be considered for scholarship aid, a ministerial student must be registered as a student or accepted for admission and must submit the required application for each aid period. The application deadlines shall be July 1 and December 1 of each fiscal/academic year.
- 5. The scholarship aid funds earned in each fiscal year may be awarded twice during the succeeding fiscal year, no later than August 1 and January 1. Hence, at least half of the annual earnings received shall be reserved for the second distribution of that fiscal/academic year.
- 6. The scholarship aid funds, together with the name of each recipient, shall be forwarded directly to the financial office of the seminary of other institution no later than August 1 and January 1.
- 7. The available funds shall be awarded to qualified ministerial students in amounts of not more than \$750 in any aid period, the amount to the determined by the availability of funds and the number of qualifying ministerial students. If circumstances warrant, priority in awarding grants shall be established by the following criteria:
  - A. First Priority for scholarships will go to a person who is, or has been, an active member of First Baptist Church in Laurens, and who currently is a
    - 1. Qualified ministerial student pursuing a basic professional degree or an advanced graduate degree in a seminary owned and operated by Baptists.
    - 2. Qualified ministerial student pursuing a basic professional degree or an advanced graduate degree in an accredited university affiliated with Baptists.
    - 3. Qualified ministerial student pursuing a basic professional degree, or an advanced graduate degree, in an accredited seminary or university not included in the two preceding priority categories.

- 4. Qualified ministerial student pursuing a pre-seminary undergraduate degree in an accredited college or university.
- B. Other consideration will be given to a student, including an international student, who is a
  - 1. Qualified ministerial student pursuing a basic professional degree or an advanced graduate degree in a seminary owned and operated by Baptists.
  - 2. Qualified ministerial student pursuing a basic professional degree or an advanced graduate degree in an accredited Baptist seminary or an accredited Baptist university not included in the preceding category.
- 8. After the second distribution of scholarship grants on or before January of each fiscal/academic year, any unused portion of the annual earnings may be added to the principal of the investment or retained as earnings for future distribution.
- 9. These policy guidelines may be amended by a two-thirds vote of the Board of Deacons.
- 10. The Scholarship Committee shall make an annual report to the Deacons.
